- A. Sugar Run Farm charges a non-refundable collection & insemination fee for each cover
- B. Mare is booked specifically by name & booking may not be transferred without written consent
- C. One mating certificate per mare will be issued each year by request
- D. Service Fee is due & payable when the mare produces a live foal or the ownership thereof changes whichever occurs first. A live foal is able to stand & nurse unassisted. A 1.5% monthly service charge will be added to any balance over 30 days outstanding.
- E. All accounts pertaining to the above mare or client must be paid in full before mating certificate is issued
- F. If a mare fails to produce a foal & the fee has been paid, the fee will be refunded provided that the claim is accompanied by a veterinary certificate no later than 30 days after the mare was due to foal
- G. In the event the semen is transported off premises for insemination, Sugar Run Farm will not be responsible for the result of the insemination of the above mare
- H. In the event legal assistance is required to collect charges accrued hereunder, all expenses including reasonable attorney's fees incurred by Sugar Run Farm shall be borne by the undersigned purchaser
- I. All barren mares are required to undergo examination for genital tract infection and a statement of negative culture is to be furnished to Sugar Run Farm
- J. In the event this agreement is executed by the agent of the owner, authorized or otherwise, such agent unconditionally guarantees the prompt payment of the service fee plus any & all amounts due hereunder as well as the performance of all the other obligations hereunder
- K. The agreement & application or construction thereof, shall be governed exclusively by its terms & by the laws of the state of Delaware & purchaser agrees to submit to the jurisdiction & venue of the courts of Delaware
- L. This agreement is only valid when signed by both parties
